4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.

Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment of antihistamine overdose should be symptomatic and supportive and may include the following: Administer activated charcoal as a slurry. For severe tachycardia, use beta blocking agents such as esmolol as a temporizing measure. For Torsades de Pointes: Administer magnesium, isoproterenol, and/or atrial overdrive pacing to stable patients. Hemodynamically unstable patients may require electrical cardioversion. Correct electrolyte abnormalities. For seizures, administer intravenous benzodiazepines. If seizures recur, consider phenobarbital. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. For hypotension: Infuse 10 to 20 mL/kg isotonic fluid. If hypotension persists, administer dopamine or norepinephrine. For agitation or dystonia, administer oral or intravenous benzodiazepines. Hemodialysis, hemoperfusion, peritoneal dialysis, and repeat-dose activated charcoal are not effective in removing antihistamines. (Meditext)
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
