## 4. First-aid measures

## 7. Handling and storage

<b>Precautions for safe handling</b>	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Use of a designated area is recommended for handling of potent materials. ### Appropriate engineering controls

No open handling. For laboratory operations, use approved ventilation or containment system (biological safety cabinet, ventilated balance enclosure, glovebox). Cover all containers for solutions and slurries while being transferred.

Base the choice of skin protection on the job activity, potential for skin contact and solvents and reagents in use. Do not wear protective garments in common areas (e.g., cafeterias) or out-of-doors.

#### Respiratory protection

Use a powered air-purifying respirator (PAPR) with HEPA filters, disposable outerware and head cover for spill cleanup. Choose respiratory protection appropriate to the task and the level of existing engineering controls.

Wear appropriate thermal protective clothing, when necessary.
