General information

Provide general supportive measures and treat symptomatically. Progestins: Single acute doses will seldom result in toxicity. Supportive treatment is adequate in most situations. For chronic toxicity, obtain a baseline CBC, hepatic and renal function tests, and treat symptomatically.

Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
