4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.
Eye contact	Rinse with water. Get medical attention if irritation develops and persists.
Ingestion	If ingestion of a large amount does occur, call a poison control center immediately. Rinse mouth. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Do not induce vomiting without advice from poison control center.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment may include the following: Administer activated charcoal as a slurry. Perform gastric lavage after ingestion of a potentially life-threatening amount of poison if it can be performed soon after ingestion (generally within one hour), unless contraindicated. Control seizures first. Use caution with fluid administration as pulmonary edema has been reported. Avoid over hydration. For hypotension, infuse isotonic fluid. If hypotension persists, administer dopamine or norepinephrine. Monitor vital signs frequently. Monitor fluid and electrolyte balance carefully. Meprobamate is effectively removed by hemodialysis or hemoperfusion. For seizures, administer diazepam. Consider phenobarbital if seizures recur after diazepam.

General information	Remove from exposure. Remove contaminated clothing. 7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
