<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

<b>Precautions for safe handling</b>	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. ### Carcinogenicity

Knowledge about carcinogenicity is incomplete.

In two-year studies in rats given naltrexone, there were small increases in the numbers of testicular mesotheliomas in males and tumors of vascular origin in both sexes. Only the incidence of vascular tumors in females (4%) exceeded the maximum (2%) reported in historical control groups. No evidence of carcinogenicity was observed in several other two-year studies in mice or rats receiving naltrexone.
