4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Wash off with soap and water. Get medical attention if irritation develops and persists.

Ingestion	Rinse mouth. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Get medical advice/attention if you feel unwell.
Most important symptoms/effects, acute and delayed	Anticholinergic effects. Pharmacologically active material. Occupational exposure may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of anticholinergic overdose may include the following: Do not induce vomiting. Gastric decontamination may be successful, even if delayed. Administer activated charcoal as a slurry. To reverse anticholinergic delirium, administer physostigmine. For tachydysrhythmias with signs of hemodynamic instability, treat with physostigmine or intravenous beta blockers. For QRS widening or ventricular tachycardia, administer sodium bicarbonate. If sodium bicarbonate is unsuccessful, consider lidocaine. For seizures, administer intravenous diazepam or lorazepam. If seizures recur, consider phenobarbital. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte imbalances, and hypoxia. For agitation, with and without hypertension and tachycardia, administer intravenous benzodiazepines. For severe hypertension, administer nitroprusside, labetalol, nitroglycerin, or phentolamine. For hyperthermia, treat with external cooling and avoid phenothiazines. For hypotension, administer isotonic fluid. If hypotension persists, consider dopamine or norepinephrine. For rhabdomyolysis, administer saline. Monitor input and output, serum electrolytes, CK, and renal function. Diuretics may be necessary to maintain urine output. Urinary alkalization is NOT recommended.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Wear appropriate personal protective equipment. Avoid inhalation of dust from the spilled material. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. For personal protection, see section 8 of the SDS.
Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
Conditions for safe storage, including any incompatibilities	Store in tight container. This material should be handled and stored per label instructions to ensure product integrity.
