### 4. First-aid measures

**Inhalation**

If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if the substance is inhaled. Call a physician if symptoms develop or persist.

**Skin contact**

Remove contaminated clothing immediately and wash skin with soap and water. In case of eczema or other skin disorders: Seek medical attention and take along these instructions. Wash clothing separately before reuse.

**Eye contact**

Rinse with water. Get medical attention if irritation develops and persists.

**Ingestion**

Rinse mouth. Get medical attention if symptoms occur.

**Most important symptoms/effects, acute and delayed**

Pharmacologically active material. Occupational exposure may cause physiological effects.

**Indication of immediate medical attention and special treatment needed**

Provide general supportive measures and treat symptomatically. Sulfonamide: Administer activated charcoal as a slurry. For hypotension, infuse with 10 to 20 mL/kg isotonic fluid, place in Trendelenburg position. If hypotension persists, administer dopamine or norepinephrine. If kidney function is normal, consider diuresis to obtain a urine flow of 3 to 6 mL/kg/hr. For anuria or agranulocytosis, dialysis and/or isolation should be considered. Obtain a baseline CBC, hepatic and renal function test. For seizures, administer a benzodiazepine. Consider phenobarbital if seizures recur. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. Sodium bicarbonate may be given to raise the pH of the urine and reduce the danger of crystalluria. For anaphylaxis, establish open airway and treat with epinephrine and diphenhydramine. Hemodialysis is only moderately effective in eliminating sulfonamides; peritoneal dialysis is not effective.

**General information**

Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

### 5. Fire-fighting measures

### 6. Accidental release measures

**Personal precautions, protective equipment and emergency procedures**

Keep unnecessary personnel away. Wear appropriate personal protective equipment. Avoid inhalation of dust from the spilled material. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. For personal protection, see section 8 of the SDS.

<b>Methods and materials for containment and cleaning up</b>	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.
<b>Environmental precautions</b>	Avoid discharge into drains, water courses or onto the ground.
<b>7. Handling and storage</b>	
<b>Precautions for safe handling</b>	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
<b>Conditions for safe storage, including any incompatibilities</b>	Store in tight container. This material should be handled and stored per label instructions to ensure product integrity.
